We are working together with numerous marketers to help us expand our platform's reach internationally. The marketing plan is ready, we can start this plan within 6 months. We have discussed privacy and legislation rules internationally with various lawyers to ensure that our platform is fully compliant with all applicable laws and regulations.

We have a list of potential customers, including many international companies with whom we have good contacts, and our platform is expected to be of interest to both B2B and B2C customers. We offer our services at an affordable price, making us an attractive option for companies of all sizes.
